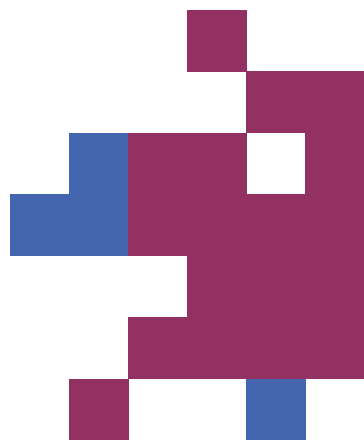

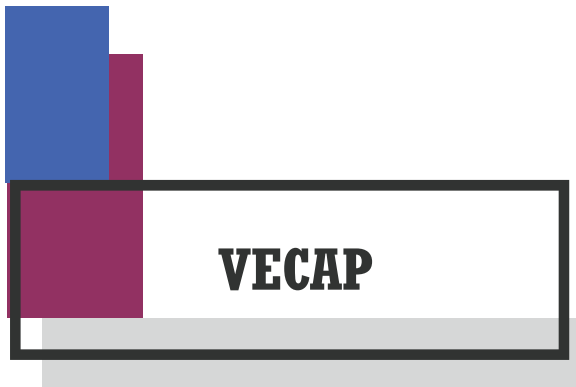

Vocational Evaluation and Career Assessment Professionals (VECAP) is a nonprofit organization whose membership of professionals provide or are interested in vocational evaluation and career assessment services. Members work in a variety of fields including rehabilitation, vocational and special education, corrections, job training, employment and career development, insurance and personal injury, welfare programs, and business and industry.

Mission

The VECAP organization is committed to improving and advancing the fields of vocational evaluation and career assessment services.

VECAP, formerly known as the Vocational Evaluation and Work Adjustment Association (VEWAA) and established in 1967, underwent a name change in 2003. The name was changed to better reflect the focus of the organization and its independent status from the National Rehabilitation Association.

Goals

- Promote the highest ethical professional standards.
- Build on the body of knowledge that comprises these professions.
- Educate the general public about the value, purposes, and availability of vocational evaluation and career assessment services.
- Ensure that the national, state, and local policies are aligned with the best interests of consumers of vocational evaluation and career assessment services and support the professions.
- Encourage the initiation and utilization of research among vocational evaluation and career assessment practitioners.
- Promote and encourage communication, cooperation, and collaboration among professionals trained and qualified to provide these services.



VECAP Activities

- Promote professional development through workshops, conferences, and training programs at the national, regional and state level, and in cooperation with local universities. In particular, VECAP conducts the National Forum on issues on vocational assessment on a biannual basis.
- Set standards for the practices of vocational evaluation and career assessment
- Publish scholarly and newsworthy materials through the VECAP Journal and the VECAP Newsletter.
- Monitor legislation and work with policy makers and the general public in relation to standards
- Maintain and update the VECAP Glossary to help decide current practices
- Recognize the achievements of members through national and state awards
- Provide core members on CCWAVES, the national certifying body for Vocational Evaluators
- Provide minimum standards to accreditation agencies for Vocational Evaluation service providers and programs
- Collaborate with other national organizations.
